

# EQUIPMENT TERMS & CONDITIONS OF USE

---

**No Roodebloem Studios equipment is to be used on the beaches or dunes unless prior consent has been arranged.**

**Rental Charges:** Equipment is charged at daily rates, which shall accrue from the time the equipment leaves the rental premises, Roodebloem Studios, until its return. Full rental charges will apply to all damaged equipment until repaired or replaced. A surcharge of R150 will be charged for after hours or weekend opening for clients.

**Loss or Theft:** A rental fee shall be charged on equipment that is lost or stolen until Roodebloem Studios is reimbursed for the full replacement costs of the equipment.

**Damaged and cleaning charges:** The renter shall be fully liable for any and all damage to all equipment hired, irrespective of the cause of damage. Equipment must be returned in the same condition it was in when signed out, to avoid damage and / or cleaning costs.

**Insurance:** All Roodebloem Studios equipment carries compulsory insurance which is charged at 10% of the full rental fee. If a half day rental has been arranged, a full day insurance figure is still applicable. Should damage / theft / loss occur, the excess is payable by the renter. Excess is charged at 10% of the replacement cost of the item(s), subject to a minimum of R5000. A rental fee will be charged on all equipment that has been stolen / lost / damaged until the items are replaced, repaired or found.

**Uninsured Risks:**

- Theft from an unattended vehicle unless stolen from a locked boot.
- Dismantling of any equipment.
- Confiscation of equipment.
- Loss of data.
- Certain African countries.

**Indemnity:** The renter indemnifies Roodebloem Studios cc against any liability, loss or claim irrespective of the cause of such liability, loss, damage or claim whether from the renter or any affiliated parties directly or indirectly

**Equipment Performance:** All equipment is inspected by qualified staff before and on return of each rental. The renter must understand the operations and limitations of the equipment. Failure of such will not be accepted as a reason for non-payment of hiring fees. In the event of equipment failure, Roodebloem Studios, at its own discretion can be held responsible only for the rental charges and not for any related costs.

**Spare Lamp Policy:** Missing / broken lamps or filaments and / or excessive burnouts will be charged at 100%.

**Collection/delivery of Equipment:** The renter shall be responsible for the collection and return of the equipment within the date / time agreed upon. Should the renter be unable to collect/return the equipment timeously and requests collection / return, the renter shall be responsible for all courier / freight costs. Should there be any delays, the renter shall still be held responsible for rental fees and transport charges. Shipping handling is out of our costs as well as rental fees and transport costs.

**Cancellation policy:** Should the renter cancel an order less than 24 hours before the confirmed booking date, a fee pro rata of the scheduled rental rate shall be charged and / or loss of reservation privileges will occur.
